



**Privacy Notice and Request for Parental Consent**  
**(Minors Under the Legal Age)**  
**Westinghouse Global Visitor Management**

This Privacy Notice (“Notice”) is to inform you about the collection, use, and sharing of your child's personal data.

When we say “Westinghouse” (“Westinghouse”, “we”, or “us”), we mean jointly and severally Westinghouse Electric Company LLC, Westinghouse UK Holdings Limited, their wholly owned or controlled subsidiaries, affiliates and joint ventures, and all organization units owned, managed, or reporting to them and their senior management anywhere in the world.

We seek your consent to capture and use your child’s personal data for the purposes outlined below in association with the event of ***Global Visitor Management***.

**Types of Data Collected:**

We may collect and process the following personal data of your child as part of the event:

- First Name, Last Name, Full Name
- Date of Birth (where applicable for compliance purposes)
- Age (where applicable for compliance purposes)
- Citizenship (where applicable for compliance purposes)
- Dual Nationality / Previous Citizenship (where applicable for compliance purposes)
- Any Other Unique Identifiers (where applicable)

**Purpose of Data Collection:**

We may use the Personal Data we collect for one of more of the following purposes:

- **Physical Security Access Management:** For example, ensuring that all visiting personnel to a Westinghouse location are properly vetted before being allowed on the premises.

- **Regulatory and Compliance Purposes:** For example, compliance with global laws and regulations, such as trade compliance, sanctions compliance, etc.

**Legal Basis for Processing:** We will process your child's personal data based on the following legal bases:

- **Consent:** For example, by you providing consent for us to use and handle your child's personal data in relation to visitor management activities.
- **Legitimate Interest:** For example, managing physical site security and access management.
- **Legal Obligation:** For example, where necessary for compliance with a legal obligation to which we are subject to (i.e., trade compliance, sanctions compliance, etc.).

**Data Sharing:** We will not share your child's personal data unless required to do so for a compliance or regulatory requirement.

**Data Retention:** We will retain the personal data for as long as necessary to fulfill the purposes outlined above unless you withdraw your consent.

For purposes of regulatory and compliance requirements, we may retain your child's personal data for up to a period of no more than 5 years.

**Data Anonymization and De-Identification:** For the protection of your child's sensitive personal data, we will anonymize and/or de-identify where possible.

**Your Rights:** You have the right to:

- Withdraw your consent at any time
- Request access to your child's personal data
- Request correction or deletion of your child's personal data
- Object to the processing of your child's personal data

**Security Measures:** We implement appropriate technical and organizational measures to protect your child's personal data against unauthorized access, alteration, disclosure, or destruction.

**International Data Transfers:** If your child's personal data is transferred to and processed in countries outside of your home country, we will ensure that appropriate safeguards are in place to protect the data.

**Automated Decision-Making:** We do not use your child's personal data for automated decision-making or profiling.
